Prices might be adjusted subject to a statutory VAT change.

The price is given in CZK per 1 bed/day including VAT, with minimum residence of 30 continuous calendar days.

All accommodation areas are provided to employees of the CTU on the basis of an application, which the immediate superior of the employee recommends and which is confirmed by the Personnel Department of the relevant section of the CTU.

If a "CTU employee" residing in a CTU dormitory is staying alone in a double room as a single use room, they may ask the SFA (economic manager) to designate the room as a single room, with the current price as listed in the valid Price List for CTU employees being raised by 70%.

The sections of the CTU may pay part of or the entire price for accommodation of the specific employee to the SFA on the basis of Intra-organisation Agreements.

Only the Director of SFA CTU in Prague or the Rector of the CTU in Prague may grant an exception to the rules for providing employee accommodation.

Bubeneč\* is valid after the complete reconstruction of the dormitory.
